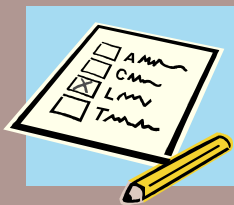

Another huge thank goes out to **Steve Nelson**, Building Official for the City of Shoreview, for his informative presentation on "The Fundamentals on Roofing, Siding and Windows" and recent code changes. Steve has been a huge advocate of MBPTA and we want to thank him greatly for his support!



As a result of the recent Code changes, did you know that now.....

1) No roof overlays will be allowed in the Metropolitan Area—this includes detached accessory structures.

2) All **new** basements require an egress window and **every** sleeping room requires an egress window.

Exception—Basements used only to house mechanical equipment and do not exceed 200 square feet need not to have an egress window.

3) The maximum stair rise is 7-3/4 inches and the minimum tread depth is 10 inches.

4) Guardrails on decks, porches, balconies, ramps or raised floor surfaces 30 inches or more above the floor or grade shall not have any openings greater than 4 inches.

Exception—Openings for required guards or sides of stair treads shall be no larger than 4-3/8 inches.



Just For Fun

Crickets are sensitive to changes in air temperature, and chirp at faster rates as the temperature rises. If you've a mind to, it is possible to use the chirps of the cricket common throughout the North America to gauge temperature. To get a rough estimate of the temperature in degrees Fahrenheit, count the number of chirps in 15 seconds and then add 37. The number you get will be an approximation of the outside temperature. This formula is said to be accurate within one degree. A variation is to count the chirps in 13 seconds, and add 40.

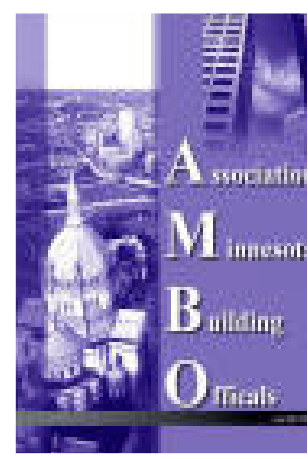

## ***Safety organization cannot explain why some smoke detectors did not detect smoke***

It's a serious problem that affects millions of smoke detectors, and it probably affects the ones in your home right now.

Tests conducted by WTHR and area fire departments have shown in slow-burning smoky fires, the most popular type of smoke detector in the United States may NOT detect smoke.

The testing showed some ionization smoke alarms (the least expensive kind which is now estimated to be in more than 90% of all U.S. households) did not sound until long after they were surrounded by thick smoke and dangerous carbon monoxide gas. In some of the tests, they did not activate at all.

So then how did those smoke alarms get a seal of approval from [Underwriters Laboratories](#), one of the world's leading testing and safety organizations?

A UL seal means a smoke alarm is "listed" by the organization which has determined the smoke detector meets industry standards for safety and effectiveness. The UL seal is very powerful. It is considered proof that a product works, and the nation's largest smoke alarm manufacturers defend their ionization smoke alarms by pointing out they've been tested and approved by Underwriters Laboratories.

"The reality is, if it's a UL listed smoke alarm, when that smoke hits the alarm, it will sound the alarm," said UL consumer affairs manager John Dregenberg.

Dregenberg told 13 Investigates that all UL-approved smoke alarms work because they are tested inside UL's 1.5-million-square-foot testing facility near Chicago to make sure they meet strict standards.

But UL admits it cannot explain why multiple tests conducted by WTHR and fire departments from Indianapolis, Wayne Township, Brownsburg and Speedway showed ionization smoke detectors that did not activate in rooms full of heavy smoke.

The following exchange is from a conversation between Dregenberg and 13 Investigates:

**Segall:** Do we agree that in a situation like that the smoke alarms should be going off?**Dregenberg:** There should be an alarm sounding... what we're really looking at is when the smoke concentration in a room is a hazard to human life,

that's when the smoke alarm should go off.

**Segall:** But we're talking about a room full of smoke.

**Dregenberg:** The fact is we know if it's a working smoke alarm, when the smoke hits that alarm, it will sound.

**Segall:** That just doesn't make sense. You stated when the smoke hits the alarm, we know it's going to go off. But yet we see situations where that doesn't happen.

**Dregenberg:** I'm talking about from a scientific standpoint, when the smoke gets to the alarm in the proper density in the proper concentration, it will go off.

**Segall:** Is there any scientific explanation for why, in this real world situation, we have smoke detectors that are not going off in a room full of smoke?

**Dregenberg:** I really don't know.

Dregenberg did point out all of the tests conducted by WTHR and Indiana fire departments are considered unscientific. And he is right.

### Scientific testing

That is why WTHR visited the laboratory of Dr. Don Russell in College Station, Texas. His lab is inside an old home on the campus of Texas A&M University, and it is where Russell has tested hundreds of smoke alarms over the past ten years.

"This is science," said Russell, a professor of electrical and computer engineering. "I've been doing this a long time."

During WTHR's visit, Russell and some of his engineering graduate students set slow smoky fires on polyurethane couch cushions inside the lab to test the response time of six ionization and six photoelectric smoke alarms.

The tests were conducted in a dark room so the researchers could scientifically monitor smoke levels with light obscuration meters -- the same way UL tests smoke levels. Infrared

cameras and high-tech computer programs constantly monitored the smoke and the alarms, and allowed the research team and 13 Investigators to watch the tests on a computer monitor from a nearby room -- safe from smoke and toxic gasses.

The results of the Texas A&M tests were nearly identical to those in Indiana.

The average activation time of the photoelectric smoke alarms was 10 minutes and 32 seconds faster than that of the ionization smoke alarms. Three of the ionization detectors did not activate until well after the amount of smoke in the room exceeded acceptable UL levels. Those three alarms sounded at an average smoke obscuration level of 14.9%, which means if you were in the room at the time the smoke detectors sounded, thick smoke would have prevented you from seeing an object -- such as a door or a person -- seven feet away from you.

(UL's safety standard for smoke alarms indicates that a smoke alarm must activate before 10% smoke obscuration. That means the smoke density surrounding the smoke alarm must not exceed 10% per foot or, put another way, you could still see an object ten feet away.)

### "A big problem"

"After an hour, we had fifty percent of the smoke detectors -- ionization smoke detectors -- not sounding," Russell said. "You saw it. I saw it. Our eyes didn't lie. The smoke was there. It was scientifically measured on both side of the smoke detectors. It's clearly thick and those smoke detectors were not going off. I call that a big problem."

It's a problem Russell has seen with ionization smoke alarms since he first began testing smoke detectors a decade ago. He says in smoldering fires, his tests show at least one in five ionization smoke alarms never sounds at all.

And yet those alarms are approved by UL. Doctor Russell says he thinks he knows why:

"Their science isn't any good, frankly. As a scientist, practicing science that doesn't replicate what the world really is in terms of physics is worthless."

Russell and other critics of UL say for decades, smoke detectors have been tested in laboratory settings that do not reflect real-life scenarios. They also argue UL's testing standard is outdated.

Some of the people who help design the standard for Underwriters Laboratories agree the current testing process for smoke alarms is long overdue for change.

Introductions took place.

There were no corrections to the minutes. Robbie Hiltz made a motion, seconded by Robin Roscoe, to approve the minutes of May 22, 2007. Motion passed unanimously.

Treasurer I Harmer gave the Treasurer's Reports for June 2007, noting that expenditures were \$134.58 with \$150 in deposits, and July 2007 had expenditures of \$280.41 with no deposits. She also reported the balance in our account (copy of the reports are attached).

Member Engberg also described the classes for the U of M education in January. She again indicated that she would get these descriptions to the Secretary to be placed in the next newsletter. She added that one of the educational days would be a "panel discussion" with a question and answer session. She also noted that the U of M bookstore would be at two of the education days so that books could be purchased on site if needed.

She added that an MBPTA booth will be available for both the January and February educations and that staffing for the booths are needed. More information regarding dates and times would be placed in the next newsletter as well.

Member Engberg informed the group that the U of M was requesting authorization from MBPTA for their endorsement and the use of the MBPTA logo for education activities regarding permit technicians. She read aloud a draft resolution that she prepared regarding this issue. She noted that the major change in the U of M education brochure was that MBPTA, as well as the other chapters, was now shown as an endorser not a sponsor.

Robbie Hiltz made a motion, seconded by Patti Wasmund, to approve the resolution entitled, "A Resolution Whereby the Minnesota Building Permit Technicians Association (MBPTA) Authorizes the Endorsement of and the Use of the MBPTA Logo for Education Activities for Building Permit Technicians". Motion passed unanimously.

Bylaws - President Lukoskie reported that a draft copy of the bylaws would be available at the September meeting for approval at the November meeting. She encouraged input from the members regarding any revisions. Both Members Engberg and Wasmund requested copies be forwarded to them for review.

**Communications Committee** - No report.

**10K Lakes** - Member Steve Nelson informed the group that he had attended the 10K Lakes summer conference at Cragun's Resort in Brainerd. MBPTA Vice-President Pease also attended. Mr. Nelson briefly described the conference and the facility and stated that the conference in an excellent way to meet new people and network.

Member Nelson also added that there were six recipients of the 10K Lakes scholarships and one of our own members, Kristina Beckfeld, a BIT student from the City of Friday, was one of the recipients.

**State Advisory Board** - Neither Member Levitski or Member Singer were able to attend the last committee meeting. However, Member Axel reminded the group that there is a four-year bachelor BIT program available through Southwest State University and also that all BIT classes at Inver Hills and North Hennepin Community Colleges will be available on line this fall. There will also be some web-enhanced classes available.

### General Business

**Region III** - President Lukoskie participated in a phone conference meeting on June 14. She announced that the Region III Committee has approved the "Brett Snyder Award" and that the first one will be presented at the Region III Institute in February 2008. She also mentioned that Region III approved their education endorsement policy, and is working on their guidelines for Region III endorsement of candidates and representatives policy. Region III would like to schedule a meeting at the AMB in Reno and an approval was made to purchasing pins. It was suggested that the Region III minutes be placed on the MBPTA website so that all members have access to them.

**Combining Education/Annual School Committees** - this item discussed previously in the meeting. At that time President Lukoskie announced that individuals are working on the bylaw changes in this area and that a draft copy of the bylaws will be submitted at the September meeting.

**2007 ICC ABM** - President Lukoskie announced that she would be attending the Annual ICC Education conference in Reno, Nevada. She expressed that she would like another board member to attend to assist her with the meetings and other activities that will be taking place there. She informed members that the cost from the MBPTA budget for two people to attend the conference would be \$2,300 and that her registration fee of \$400 would be waived since she is the MBPTA President. She expressed that she would feel more comfortable asking the membership's permission to send another officer even though the Bylaws indicate expenditures such as this one can be made with the approval of two officers. Member Axel mentioned that he would also be at the conference to assist President Lukoskie in any way he could. Vice-President Pease indicated that she would be willing to make the trip but needed approval from her employer for the time off before committing.

A lengthy discussion ensued regarding whether or not the second person attending the conference would have to be an officer or could it be any MBPTA member.

Roger Axel made a motion, seconded by JoAnne Beckes, to use MBPTA funds to send two members to the 2007 ICC Annual Education in Reno, Nevada to help promote the 2008 ABM here in Minnesota. Motion passed unanimously.

At this time Member Axel distributed copies of the 2008 AMB logo that will be used for T-Shirts, pins, post-it notes, cups, etc.

**Caring for the Community** - No Report.

**Nominations for Officers** - President Lukoskie reminded members that we need to start thinking about 2008 officer nominations and that if there were any questions to e-mail her directly.

**Open Floor** - President Lukoskie mentioned an e-mail that she received from the Building and Fire Safety Official at the City of Turnwater in Washington State complimenting our newsletter. Kudos was given to Secretary Benesch for her work on the newsletter.

President Lukoskie provided a little information regarding the Oregon Permit Technicians noting that there were 58 certified technicians in that State an increase of 11 just from January 2007.

She also mentioned that Secretary Benesch had received an e-mail from Member Barb Williams of the Communications Committee indicating that Williams had on the website, the latest approved minutes, the July newsletter, October's Legal Strategies Seminar information and sign-up sheet, U of M and Region III Institute dates, and links to additional permit tech websites.

**Adjournment** - Jeanne Witczek made a motion, seconded by Debi Hegedus, to adjourn the meeting at 10:45 a.m. Motion passed unanimously.

Immediately following the meeting Steve Nelson, Building Official for the City of Shoreview, gave an informational PowerPoint presentation regarding the fundamentals of roofing, siding and windows.
